6. Accidental Release Measures

6.1 Personal precautions, protective equipment and emergency procedures

6.2 Environmental precautions

Dust deposits should not be allowed to accumulate on surfaces as these may form an explosive mixture if they are released into the atmosphere in sufficient concentration. Avoid dispersal of dust in the air (i.e., cleaning dusty surfaces with compressed air). Non sparking tools should be used. Prevent product from entering drains. Use personal protective equipment. Take up mechanically and collect in suitable container for disposal. Prevent product from entering drains. Keep in suitable and closed containers for disposal.
